2. Terms of Reference of CBU:

- a. Complete FRAC assessment through mapping of roles at every level.
- Conduct department/unit-wise HR audits in collaboration with CBC to map existing competency gaps.
- c. Co-create, update and implement the Annual Capacity Building Plan (ACBP) for the Department in collaboration with CBC.
- d. Develop KPIs for monthly/annual monitoring outputs and outcomes of Mission Karmayogi in DOT/CPSEs/CDOT.
- e. Monitor and report the progress of implementation of Annual Capacity Building Plan (ACBP) to CBC.
- f. Facilitation of Training and non-training interventions for organizational capacity building in partnership with experts
- g. Arrange for third party evaluation of Mission Karmayogi in various DOT organisations.
- 3. The CBU of DoT shall be responsible for coordination with CBC and implementation of various Capacity Building programmes/ intervention for all personnel /employees under the Department of Telecommunications on continuing basis. It shall meet as often as necessary to draw up Capacity Building Plans for every employee but not less than once in every quarter.
